## Visit Check List

### Please read prior to bringing a group to Roche Court

1. Please adhere to **social distancing** guidelines. There will be hand sanitizer available at the front door and the toilets in the car park will be cleaned regularly and kept well stocked with paper towels and soap. We encourage groups to wear a **face covering** when entering any of our indoor gallery spaces.
2. Please ensure that students wear **appropriate outdoor clothing** and sensible non-slip footwear. We recommend wellington boots and waterproof jackets if the weather is wet.
3. Every student should have a **clipboard with paper / sketchbook and pencil**. Please ensure that each group leader has spare pencils. The Trust can provide additional drawing materials by request.
4. Depending on the size of your group, you may need to split your students into smaller groups prior to the visit. Please refer to your confirmation email and timetable attached to the email for details of this.
5. Please make sure students/group participants are aware of **appropriate behaviour** including
  - Not touching the sculpture or exhibits
  - Not running anywhere in the park or galleries
  - Not eating or drinking except in the designated picnic areas
  - Not depositing litter anywhere except in the bins provided
6. Permission is granted for students / staff to take **photographs** at Roche Court on the understanding that photographs are for educational purposes only and will not be published or shown in a context outside of school. No photographs may be taken of the main house which is a private home.
7. **Please remember that students will remain the sole responsibility of the school / college / university at all times during their visit.** Although every reasonable care is taken to ensure visitor safety The Roche Court Educational Trust or the New Art Centre can accept no responsibility for any accident or loss.
8. All visiting groups are responsible for their own behaviour at all times.

### Please advise the driver of the coach / minibus

1. Coaches are advised to remain on the A30 until the turning signposted for East Winterslow, Roche Court and a brown tourist sign for Shiralee B&B.
2. The entrance gates to Roche Court are automatic and work on sensors. Go closer than you think to initiate them.
3. Coaches should ignore signs to the car park and proceed through the second gates to park in front of the main house. Minibuses should proceed straight to the car park.
4. Please do not drive on the grass.
5. Please be very aware of sculptures on the grass near the main house particularly when reversing.
